MINUTES OF THE PROCUREMENT MEETING HELD ON 13-03-2026 AT 14:00 HOURS REGARDING OPENING OF TECHNICAL BID OF PREFABRICATION

A procurement committee meeting was held on 13-03-2026 at 14:00 hours under the chairmanship of Dr. Muhammad Qasim Khan, Director, Strategic Support Unit, Higher Education Department. The following attended the meeting;

2. Meeting started with the recitation of Holy Quran. The chair welcome all the participants and directed the Section Officer (General) to proceed for opening of tender on E-Pad. Accordingly, the technical bid opening process initiated and after verification of the OTP shared individually via email, opened the technical bid. The following six firms participated in the bidding process through E-Pads by submitting online bids.

- a. M/S Malik Sirajul Constructions PVT Ltd
- b. M/S Zahir Shah & Brothers
- c. M/S FB Constructions & Co
- d. M/S Broad Peak & Enterprises
- e. M/S Imran Construction Co
- f. M/S Syed Khan & Company

3. As per BSD, the preliminary evaluation was carried out on the basis of mandatory requirements. Two firms namely M/S FB Constructions & Co and M/S Imran Construction Co were qualified in the first phase whereas following four firms were disqualified due to not fulfillment of mandatory requirements:

- a. M/S Malik Sirajul Constructions PVT Ltd.
- b. M/S Zahir Shah & Brothers.
- c. M/S Broad Peak & Enterprises
- e. M/S Syed Khan & Company

4. Afterwards, detailed technical evaluation of two bids were carried out. During this stage one firm namely M/S Imran Construction Co obtained 90 score out of 100 whereas the other firm namely M/S FB Constructions & Co obtained 65 out of 100. **(Detail evaluation sheets attached duly signed by all committee members)**

5. The committee unanimously decided that tentative technical bid evaluation may be uploaded on the official website of KPPRA and Higher Education Department and E-PAD for information of general public/bidders and also decided that financial bid may be opened on 24-03-2026 at 1400 hours. The committee also decided that credentials/work orders of successful bidder will be verified before entering in the contract with the successful bidder.
