- 5. The contractor quoting their bids more than 10% below on engineer's estimates shall submit along with their bid an additional security in accordance of KPPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated 10-05-2022.
- In case the bidder quotes more than 10% below the engineer's estimate and the bid is not accompanied by the additional security then the bid shall be considered as non-responsive and the second lowest bidder and so on will be considered accordingly.
- 7. Incomplete/disfiguring/over-writing/conditional/late bids will be considered non-responsive.
- 8. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for the works, consulting and non-consulting services a listed in schedule-II of the Act.
- 9. If the financial bid of two or more than two qualified bidders are equal, then the successful bid will be declared through draw/toss by the client which shall be final and binding upon the bidders.
