TERMS AND CONDITIONS:

- She will have all rights/privileges contained in Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments made therein including Khyber Pakhtunkhwa Civil Servants (Amendment) Act. 2013 and Rules made there under.
- ii. In case of resignation, the officers will have to give one month prior notice. In absence of such notice their one month's pay/allowances shall be forfeited to Government.
- The appointee should join her post within 30-days of the issue of this Notification failing which it shall be presumed that she is not interested to join the same. Charge report shall be submitted to them. The Director, Higher Education, Khyber Pakhtunkhwa, Peshawar shall furnish a certificate to the effect that the appointee has joined her post or otherwise, after one month of the issue of this Notification.
- iv. She will be on probation for a period of 01 year extendable for another one year.
- v. She will undergo mandatory training for the purpose of promotion, as the case may be.
- vi. She will get pay of BPS-17 including usual allowances as admissible under the rules. She will be entitled to annual increment like other Civil Servants.
- vii. Her appointment will be subject to verification of their documents/testimonials during the period of probation.
