- ii. In case of resignation, the officer will have to give one month prior notice. It such notice her one month's pay/allowances shall be forfeited to Government.
- iii. The appointee should join their posts within 30-days of the issue of this Notifical which it shall be presumed that they are not interested to join the same. Charge be submitted to all concerned. The Director, Higher Education, Khyber Park Peshawar shall furnish a certificate to the effect that the appointees have joined or otherwise, after one month of the issue of this Notification.
