OFFICE ORDER

In pursuance of Rules 10(4) of Khyber Pakhtunkhwa: Govt. Servants (Appointment, Promotion and Transfer) Rules, 1989 read with Establishment and Administration Department (Regulation Wing) Notification No. SO (R-VI) E&AD 1-3/2015 dated 19.04.2016 and the Govt. TERMS & CONDITIONS

 They will produce Health & Age certificates from Medical Superintendent/Civil Surgeon.

- They will have all the rights/privileges contained in Khyber Pakhtunkhwa Civil Servants Act, 1973 with all amendments made therein including Khyber Pakhtunkhwa Civil Servant (Amendment) Act, 2013 and Rules made there under.
- iii. The appointment is subject to the condition that Degrees / Certificates / Documents must be verified from the concerned Board/University. The charge reports of the concerned appointees will be accepted after complete verification of documents. In case of fake/bogus Degrees/Certificates/Documents detected later, their appointment order would be automatically cancelled from the date of their appointment and will be reported to law enforcement agencies for legal action.
- iv. In case of resignation, the appointees will have to give one-month prior notice. In lieu of such notice their one month pay/allowances shall be forfeited to Government.
- v. They will be governed by such Rules & Regulations as may be issued from time to time by Government.
- vi. The appointees should join their posts within 30 days of the issuance of this order failing which it shall be presumed that they are not interested to join the same.
- vii. Charge report should be submitted to all concerned.
- viii. In case of disciplinary matters Khyber Pakhtunkhwa Civil Servants Act, 1973 and Khyber Pakhtunkhwa Civil Servant (Efficiency & Discipline) Rules, 2011 shall be applicable.
- They will be on probation for a period of one year extendable to another period of one year.
- x. They will get pay i.e. initial pay of BPS-11 including usual allowances as admissible under the rules. They will be entitled to annual increment like other Civil Servants.
- xi. The Appointment of the above candidates will automatically stand terminated if at any stage, it was found that the documents are incorrect and not in conformity to the eligibility criteria devised for the appointment of Junior Clerk.
